PROHIBITION OF RAGGING IN EDUCATIONAL INSTITUTIONS

Act 26 of 1997

Ragging is an act which is likely to cause insult or annoyance or fear or apprehension or threat or intimidation of outrage of modesty or injury to students. Ragging is prohibited within or outside the educational institutions.

Sl.No.	Extent of offence	Penalty
1	Teasing or embarrassing or humiliating a student	Imprisonment up to 6 months or a fine up to Rs. 1,000/- or both.
2.	Assault or use of criminal force or criminal intimidation.	Imprisonment up to 1 year or a fine up to Rs.2,000/- or the
3.	Wrongful restraint or wrongful confinement or causing	Imprisonment up to 2 years or a fine up to Rs.5,000/- or both.
4.	Causing grievous hurt or kidnapping or abducting or committing rape or committing unnatural offence.	Imprisonment up to 5years with a fine up to Rs.10,000/-
5.	Causing death or abetting or abetting suicide.	Imprisonment for life or for a term up to 10 years with fine up to Rs.50,000/-

Note:

1. A student convicted of any or the above offences, will be expelled from the college.
2. A Student imprisoned for more than six months for any of the above offences will not be admitted in any other college.
3. A Student against whom there is prima facie evidence of ragging in any form will be suspended from the college immediately
